

PRIVACY POLICY OF WY- GO / WANDERBLY

USE OF WEBSITE

This Website is provided solely to assist you to gather travel information, determine the availability of travel-related goods and services, make legitimate reservations or otherwise transact business with travel suppliers, and for no other purposes.

This Website ("Website") is offered to you on condition that you accept our Terms and Conditions. We ask that you read our Terms and Conditions and are familiar with them. You should also read our Privacy Policy which governs your use of the Website of WY-GO/ WANDERBLY. By making use of or accessing our Website, making any reservations, of a travel package or any other of our provided services through our Website, or contacting any of our agents/ employees, you agree to our Terms and Conditions and they are therefore in force and apply. Should you not agree to our Terms and Conditions we ask that you refrain from making any bookings through our Website or through our agents/ employees.

- 1.1. We respect your privacy and will take all reasonable measures to protect it, as more fully detailed below.
- 1.2. Should you decide to register as a user on the Website, or any of our social media platforms we may require you to provide us with personal information which includes but is not limited to -
 - 1.2.1. your name and surname;
 - 1.2.2. your email address;
 - 1.2.3. your physical address;
 - 1.2.4. your gender;
 - 1.2.5. your mobile number; and
 - 1.2.6. your date of birth.
- 1.3. Should your personal information change, please inform us and provide us with updates to your personal information as soon as reasonably possible to enable us to update your personal information.

- 1.4. You may choose to provide additional personal information to us, in which event you agree to provide accurate and current information, and not to impersonate or misrepresent any person or entity or falsely state or otherwise misrepresent your affiliation with anyone or anything.
- 1.5. Subject to clause 1.6 below, we will not, without your express consent:
 - 1.5.1. use your personal information for any purpose other than as set out below:
 - 1.5.1.1. in relation to the ordering, sale and delivery of Goods;
 - 1.5.1.2. to contact you regarding current or new Goods or services or any other goods offered by us or any of our divisions, affiliates and/or partners (unless you have opted out from receiving marketing material from us);
 - 1.5.1.3. to inform you of new features, special offers and promotional competitions offered by us or any of our divisions, affiliates and/or partners (unless you have opted out from receiving marketing material from us); and
 - 1.5.1.4. to improve your experience on our Website by, inter alia, monitoring statistical non-personal browsing habits, and to transact with us; or
 - 1.5.2. disclose your personal information to any third party other than as set out below:
 - 1.5.2.1. to our employees and/or third party service providers who assist us to interact with you via our Website, email or any other method, for the ordering of Goods or when delivering Goods to you, and thus need to know your personal information in order to assist us to communicate with you properly and efficiently;
 - 1.5.2.2. to our divisions, affiliates and/or partners (including their employees and/or third party service providers) in order for them to interact directly with you via email or any other method for purposes of sending you marketing material regarding any current or new goods or services, new features, special offers or promotional items offered by them (unless you have opted out from receiving marketing material from us);
 - 1.5.2.3. to our suppliers in order for them to liaise directly with you in the event of you have purchased a product/ package which requires their involvement; and
 - 1.5.2.4. pursuant to a corporate transaction in terms of which we sell any of our businesses or assets to a buyer of such businesses or assets.
- 1.6. We are entitled to use or disclose your personal information if such use or disclosure is required in order to comply with any applicable law, order of court or legal process served on us, or to protect and defend our rights or property.

- 1.7. We will ensure that all of our employees, third party service providers, divisions, affiliates and partners (including their employees and third party service providers) having access to your personal information are bound by appropriate and legally binding confidentiality and non-use obligations (save as permitted herein) in relation to your personal information.
- 1.8. We will -
 - 1.8.1. treat your personal information as strictly confidential;
 - 1.8.2. take appropriate technical and organisational measures to ensure that your personal information is kept secure and is protected against unauthorised or unlawful processing, accidental loss, destruction or damage, alteration, disclosure or access;
 - 1.8.3. provide you with access to your personal information to view and/or update personal details;
 - 1.8.4. promptly notify you if we become aware of any unauthorised use, disclosure or processing of your personal information;
 - 1.8.5. provide you with reasonable evidence of our compliance with our obligations under this policy on reasonable notice and request;
 - 1.8.6. upon your request, promptly return or destroy any and all of your personal information in our possession or control; and
 - 1.8.7. not retain your personal information longer than the period for which it was originally needed, unless we are required by law to do so, or you consent to us retaining such information for a longer period.
- 1.9. ***WY-GO/ WANDERBLY undertakes never to sell or make your personal information available to any third party other than as provided for in this policy, unless WY-GO / WANDERBLY are compelled to do so by law. In particular, in the event of a fraudulent online payment, WY-GO/WANDERBLY reserves the right to disclose relevant personal information for criminal investigation purposes or in line with any other legal obligation for disclosure of the personal information which may be required of it.***
- 1.10. ***Whilst WY-GO / WANDERBLY will do all things reasonably necessary to protect your rights of privacy, WY-GO/WANDERBLY cannot guarantee or accept any liability whatsoever for unauthorised or unlawful disclosures of your personal information, whilst in our possession, made by third parties who are not subject to our control, unless such disclosure is as a result of our gross negligence.***
- 1.11. ***If you disclose your personal information to a third party, such as an entity which operates a website linked to this Website or anyone other than (WY-GO/ WANDERBLY), (WY-GO/WANDERBLY) SHALL NOT BE LIABLE FOR ANY LOSS OR***

DAMAGE, HOWSOEVER ARISING, SUFFERED BY YOU AS A RESULT OF THE DISCLOSURE OF SUCH INFORMATION TO THE THIRD PARTY. This is because we do not regulate or control how that third party uses your personal information.

- 1.12. This Website makes use of “cookies” to automatically collect information and data through the standard operation of the Internet servers. “**Cookies**” are small text files a website can use (and which we may use) to recognise repeat users, facilitate the user’s on-going access to and use of a website and allow a website to track usage behaviour and compile aggregate data that will allow the website operator to improve the functionality of the website and its content. The type of information collected by cookies is not used to personally identify you. If you do not want information collected through the use of cookies, there is a simple procedure in most browsers that allows you to deny or accept the cookie feature. Please note that cookies may be necessary to provide you with certain features available on our Website, and thus if you disable the cookies on your browser you may not be able to use those features, and your access to our Website will therefore be limited. ***If you do accept a “cookie”, you thereby consent to our use of any personal information collected by us using that cookie subject to the provisions of this policy.***
